APPLICANT'S DECLARATION

- I, the undersigned Applicant hereby apply for the Term Membership at ONE°15 Marina Club (the "Club"), and the resultant privileges thereof.
- I undertake at all times to comply with and be bound by the Rules and Regulations and Bye-laws of the Club as may be prescribed and amended from time to time by the Club and/ or SUTL Marina Development Pte Ltd (the "Proprietor"). In addition to the Rules and Regulations and Bye-laws of the Club, I acknowledge and agree specifically, without limitation to the following:
 - I am fully aware and agree that the Club is a proprietary club and that membership in the Club does not confer upon me any rights, title or interest in any property or assets owned by the Club or available for use by the Club or its members.
 - I will be personally liable for all applicable membership dues and charges incurred by me, my family and my guests in the use of the Club, its facilities or any reciprocal clubs.
 - I warrant that all the information provided in this application is true and correct and that I am not a bankrupt and that no legal proceedings have been presented against me and I have not been convicted of a criminal offence. In the event the warranty given in this paragraph is breached, I accept responsibility for any loss or damage that may be suffered either by me or the Club.
 - I confirm that in consideration of the Club agreeing to consider my application for membership, this application made by me shall be irrevocable.
 - In consideration of the acceptance by the Club of my membership, I hereby agree and undertake that notwithstanding the Terms and Conditions of the Rules and Regulations of the Club, my membership shall not be transferable.
 - I understand the deposits made to the Club shall be refunded upon resignation of my Term Membership provided all outstanding amounts has been settled and all issued membership cards and car labels (if any) are returned to the Club, otherwise chargeable. Outstanding amounts may be off-set from the deposits made.
 - I understand Absent Status is not permitted under Term Membership.
 - I understand I have an option of a 1, 2 or 3-year Term Membership.
 - I understand I will be automatically deemed resigned from the Club on the expiry date of my membership tenure if no written notice (30 days in advance) is given to the Club.
 - I understand that if I wish to renew my Term Membership, I am required to write in to the Club together with the applicable renewal entrance fee for the management's approval 30 days before my existing Term Membership expires.
 - I understand each Term Membership is issued for a period of no less than 1 year and no more than 3 years and subject to the approval of the Club's management.
 - I understand the entrance fee will not be refunded upon an early resignation on my part.
 - In the event I would like to take on Corporate or Individual Membership, I understand the Club is unable to off-set the entrance fee or any other monies paid to the Club while under Term Membership for the entrance fees of Corporate or Individual Membership. I will be required to write in to the Club 30 days before my existing Term Membership expires.
 - In the event I default in any payments to the Club, be it in entrance fee, monthly subscriptions or any other monies owing to the Club, the Club shall have the rights to suspend my membership privileges and thereafter to terminate my membership. If payment is not forthcoming, and all amount paid by us shall be forfeited to the Proprietor absolutely as agreed liquidated damages and the Proprietor reserves the right to seek legal redress for all outstanding debts owing to the Club including legal costs incurred, after membership termination.
