## **ARRIVING TO SINGAPORE**

For vessels arriving to Singapore, please kindly note the following:

- It is mandatory for all yachts coming into Singapore to be fitted with an Automatic Identification System and to notify the Port Master, as least 24 hours prior to arrival in Singapore. You may send your Notice of Arrival to noa@mpa.gov.sg.
- All yachts arriving from overseas, requiring inward clearances, must tie up at the designated CIPQ zones and await clearance.

## **CIPQ Zone**

The designated CIPQ zone is as below:

Please note that you must hand over to the Immigration Officer, all Passports and Crew/ Passenger list.

- Upon clearance by the ICA officer, the Captain is to proceed to the Marina Office for registration. Please bring along the following documents:
  - 1. Registration Certificate
  - 2. Insurance Certificate
  - 3. Last Port Clearance and crew/passenger lost, checked and stamped by the ICA Officer.
- Vessels arrived in Singapore waters are required to pay port dues to MPA, and charges are according to tonnage. Port clearance can be done 24 hours in advance for departure. Please call Marina Office for further assistance
